**WRAL Classes:** - AQHA rules are applied with following exceptions:

- Youth -18 may also enter the Beginner, Amateur and Open Division. Youth may show **twohanded** in Snafflebit or Hackamore or **onehanded** on a Bit even senior horses.
- No stallions are allowed in Youth-Classes
- The Beginner division is reserved exclusively for competitors who are eligible to have or get a AQHA-NOVICE Amateur, AQHA-NOVICE Youth or NRHA-ROOKIE card.
- Beginner may show **twohanded** in Snafflebit or Hackamore or **onehanded** on a Bit even senior horses.
- In all WRAL-classes the horse does not need to be owned by the competitor.

#### **AQHA:**

- Classes are judged according to their respective rules.
- Rider has to send in the required valid membership card (or buy it at the show) as well as a copy of the horse's registration certificate.

**FLSE classes: (just for FLSE licensed riders):** AQHA rules are applied with the following exception:

- In Youth and Open classes the horse does not need to be owned by the competitor.
- The competitor needs to own an FLSE Western or Competition license, the horse does not need be registered.

#### **Waiver of Resonsibility and health requirement:**

- The exhibitor agrees that neither the show-management nor the owner of the arena accept any reponsibility for accident, loss or damage to persons, horses or properties, how so ever caused and that he comply with the rules as stated in the showannouncement. The exhibitor sending the form signed or not ( for online entry) certifies that the horses are free of disease and vaccinated against influenza, are covered by a liability insurance and that the exhibitor has a liability accident insurance on the showday. The exhibitor hereby confirm that he e will pay the expenses for a verterinary examination if such will be necessary. Owners are responsible for there dogs.
